Required Daily Supplies Acknowledgement

Please read this document carefully and sign below to acknowledge your understanding and agreement.



To ensure every child can safely, comfortably, and fully participate in the daily program, parents/guardians are responsible for providing all supplies required for their child's age, developmental stage, and individual needs.

Required Daily Supplies

Depending on your child's age and individual needs, this may include:

- Diapers, pull-ups, or other diapering supplies (where applicable)
- Baby wipes
- Two (2) waterproof wet bags when using cloth diapers
- Bottles, ready-to-feed formula, or breast milk (for infants), where applicable, and a water bottle with a covered mouthpiece.
- At least one complete change of clothing (multiple changes are strongly recommended for children who are toilet learning)
- Appropriate indoor footwear
- Weather-appropriate outdoor clothing and footwear suitable for the season and daily weather conditions
- Any other supplies identified by the Centre as necessary for your child's daily care

Parents/guardians are responsible for ensuring these supplies are replenished as needed throughout their child's enrollment.

Footwear and Clothing Requirements

Children must have safe, properly fitting indoor and outdoor footwear available each day to participate in classroom activities and outdoor play.

For the safety of all children:

- Flip-flops are not permitted.
- Crocs must be worn with the heel strap securely fastened behind the foot ("Sport Mode").
- Footwear must fit securely and allow children to safely run, climb, and participate in daily activities.

Children must also have weather-appropriate outdoor clothing available each day. Depending on the season, this may include rain boots, splash pants, a sun hat, winter boots, snow pants, mittens, a warm coat, or other clothing appropriate for current weather conditions.

Cloth Diapers

Families choosing to use cloth diapers must provide a minimum of two (2) waterproof wet bags each day for the safe storage of soiled diapers and wipes. If two wet bags are not provided, cloth diapers cannot be used that day, and disposable diapers must be supplied instead.

Insufficient Supplies

Pluto Day Care does not maintain a supply of diapers, pull-ups, wipes, clothing, footwear, bottles, formula, or other personal care items.

Children who arrive without the supplies necessary to safely participate in the program **will not be admitted into care.**

Parents/guardians must either:

- Obtain the required supplies and return to the centre with their child before **9:30 a.m.**, or
- Take their child home and return on their next scheduled day with the required supplies.

For health, hygiene, and infection prevention reasons, personal items will **not** be borrowed or shared between children.

Parent/Guardian Acknowledgement

I acknowledge that I have read and understand Pluto Day Care's requirements regarding daily supplies, clothing, footwear, and personal care items. I understand that it is my responsibility to ensure my child arrives each day with all supplies necessary to safely participate in the program. I understand that children who arrive without the required supplies will not be admitted into care until the necessary supplies have been provided, and I agree to comply with this policy.
